Applications are invited for the affiliation of Existing Engineering College/ Architecture Institutions/ Continuation / Extension of Temporary Affiliation / Permanent Affiliation / Renewal of Permanent Affiliation /New Engineering College/ New Architecture College/ Recognition of Fresh and Continuation of Research centre for the Academic year 2025-26.

A : TEMPORARY AFFILIATION:

I) Applications are invited for :

- Setting up the New Engineering / Architecture Institutions/Standalone BBA/BCA Institutions, from the Society registered under Society Registration Act 1860/a Trust registered under Indian Trust Act 1882 as Amended from time to time or a company established under a Section 8 of Companies Act 2013 and which have a Governing body
- State Government may also apply through an officer authorized by State Government

II) Applications are invited from the existing Institutions:

- for Continuation/Extension of affiliation for B.E./B.Tech./B.Arch./B.Plan./B.Voc./ B. Design/B.Sc.(Honors)/BBA/BCA/ MCA/ MBA/ M.Tech./ M.Arch./ M.Plan. Programmes
- to start New UG [B.E./B.Tech./B.Arch./B.Plan/ B.Voc./ B.Design/B.Sc.(Honors)/BBA/BCA] and PG [MCA/ MBA/ M.Tech./ M.Arch. / M.Plan.programmes/ Integrated MCA/ Integrated MBA/Integrated M.Tech.] (for the titles of the programmes which are instituted and recognised by VTU- refer Annx-II)
- for Variation in Intake in existing UG/PG programmes

- for Change of Site/Location
- for Change in the name of the Institution/ Trust/Society
- for Closure of the Institution

The institutes shall satisfy all requirements of Chapter X of VTU Act 1994/ VTU Statutes of Temporary Affiliation (<https://vtu.ac.in/pdf/affiliation/Temporary-Affiliation.pdf>) / AICTE/ Council of Architecture/ Government of Karnataka as notified from time to time.

Further, the Institutes/ Colleges have to maintain the FSR as per AICTE norms, failing which University will reduce the intake and recommend the same to Government of Karnataka.

III] Vocational programmes in existing institutes [B.Voc.]:

The institutes shall satisfy:

- a. The VTU Temporary Affiliation Statutes
- b. The AICTE norms as notified and revised by AICTE from time to time

IV] UG programme in Kannada Medium:

Institutes can also apply for B.E. Programme in Kannada medium to AICTE. One such programme with an intake of 30 for each Institute will be considered strictly in accordance with prescribed AICTE norms and will be approved by the University based on AICTE approval.

V] Following National Building Code (NBC) Guidelines:

Please refer VTU Circulars : VTU/BGM/Aca-OS/Gen-Cirs/ 2019-20/ 8943, VTU/OS-Aca/2020-21/2326 dt: 18-09-2020 and VTU/BGM/Aca/SA/Cirs/2023-24/4312 dt: 25-11-2023. The same applicable for affiliation for the year under consideration.

VI] Important Notes:

1. Application with respect A(I, II, III and IV above) will be processed as per AICTE norms stipulated in APH - 2024-27/ COA Norms
2. Approval of Apex Bodies (AICTE/ COA) is mandatory to offer all the programmes for the Academic Year 2025-26.
3. The college/Institution having variation in Intake/ Closure of the Course/Starting of the New Course/s during the Academic Year 2024-25 have to submit the Government of Karnataka approval along with Application for the Academic Year 2025-26 mandatorily.

B : PERMANENT AFFILIATION:

: Fresh and Renewal :

Applications are invited from existing colleges for Permanent Affiliation as per the VTU Statutes on Permanent Affiliation of Colleges (Amended) 2011 (visit <https://vtu.ac.in/pdf/affiliation/Permanent-Affiliation.pdf>).

Compliance of following norms is mandatory for Permanent Affiliation :

- a) *College should be recognized under 2(f) of UGC Act, 1956*
- b) *The programme for which permanent affiliation is sought*
 1. should be temporarily affiliated by VTU for a minimum continuous period of five years
 2. should have valid accreditation (as per Karnataka State Govt. Circular ED UNE 2018 dt: 17-01-2019)

C- Autonomous Colleges:

- a) Every autonomous college shall have to fill the affiliation application compulsorily as the data submitted will be used for various other applications and for submission of statistical data.
- b) If any variation in approval i.e. new programme, variation in intake, Autonomous fees structure is applicable including application fees and processing fees. (As notified VTU/BGM/Aca-OS-Cirs/2021-22/726 dt: 8-6-2021)
- c) If any autonomous College/s willing to apply for Permanent Affiliation, they are permitted to do so. However, as per Clause 15 (b) of VTU Statutes on "Permanent Affiliation of Colleges (Amended) 2011" the college have to pay the affiliation fees for permanent affiliation separately.

: D- RECOGNITION OF RESEARCH CENTRES:

Separate applications are to be filled for each department for which recognition is sought for Fresh/ continuation.

I] Recognition of Fresh Research Centres(Annual Basis):

Applications are invited for

- a) Starting of New Research Centres either in the Faculty of Engineering or in Allied / General Science in Karnataka State from Departments of teaching Institutions affiliated to VTU, Research & Development laboratories attached to Industries and such other laboratories of Research Institutions of National / Govt. Institutions.
- b) The Research Centres which are closed/discontinued during the previous year/s shall apply as Fresh Research Centers only.

II] Continuation of Recognition (Annual Basis) : During the academic year 2025-26, all the research centres will be inspected during the LIC visits.

Affiliation fees once paid will not be refunded or adjusted.
3. The colleges are required to upload the fee paid details in affiliation portal for submission of application.

5. As and when the application is submitted electronically, immediately 02 hard copies should be submitted to the University. However, each page of hardcopy shall be attested by the Principal with the seal of the college.



STARTING OF NEW UG/PG PROGRAMMES UNDER EMERGING /MULTIDISCIPLINARY AREAS

The proposals for starting and instituting for new UG/PG program/s in **Emerging /Multidisciplinary Areas** are invited from the colleges that are planning to start during the ensuing AY 2024-25. The college can refer to APH 2024-27 for the list of programs for UG/PG in the Emerging /Multidisciplinary Areas.

If the proposed program/s is not instituted under VTU, then the college has to submit the proposal for starting and instituting a new course as per the guideline mentioned below-

1. Under Graduate and Post Graduate Programs shall confirm to the Nomenclature approved and listed in Approval Process handbook of AICTE
2. College wishes to start a new program with the title not listed in approved nomenclature of AICTE, have to apply to AICTE well in advance for approval of the nomenclature.
3. All proposals for the introduction of the new program shall (Detailed Project Report should) include
 - a. History-
 1. About College-name and address, Affiliation, Year of Establishment, Type of institute, NAAC status, NIRF ranking
 2. Detail about the program being offered,- Course, department, Programme started to date, AICTE approval year with intake, NBA status.
 3. Vision and Mission of the Institution
 4. Contact Details
 - b. Objective of the New program
 - c. Scope of the new program
 - d. Job opportunities for a new program
 - e. Appropriated survey report for the confirmation of all above points
 - f. Justification shall clearly specify how the existing (similar stream) program are not fulfilling manpower requirement.
 - g. Justification shall clearly specify how the new proposed program will be fulfilling man power requirements. (If colleges are running UG/PG program, the success of such program shall be considered for the award of the new program).
 - h. The proposal should agree with man power requirements as per AICTE norms.
 - i. A new program shall be proposed after a review of existing similar program/s and shall have not more than the 40% overlap of contents of courses.
 - j. New programs shall be considered preferably in the **emerging area or in an interdisciplinary area.**
 - k. PG programs shall be awarded to an institution if the corresponding UG program in the department is accredited.
 - l. Infrastructure facility details
4. Proposal should contain Syllabus, Scheme of Teaching and Examination, as per University template. (please send request email for template/s to **sbhvtuso2022@gmail.com**)
5. If College is Autonomous then, Regulation governing the UG/PG program should be enclosed in the proposal.
6. For the UG program I & II semester common syllabus should be enclosed for reference.
