Subject: Equivalence between 2021 and 2022 scheme regarding...

Dear Sir/Madam,

This is in reference to the subject cited above, students appearing for backlog papers from the 2021 scheme must prepare and take equivalent courses/subjects from the 2022 scheme, as recommended by the Board of Studies (References 01 and 02).

## Specific Guidelines for the December 2024/January 2025 Examination;

Only students with 3rd and 4th-semester backlog papers from the 2021 scheme need to take equivalent courses/subjects from the 2022 scheme.

### **Exception for Certain Courses/Subjects**;

Some 2021 scheme courses/subjects (3rd and 4th sem) have equivalent subjects in the 6th semester of the 2022 scheme. Since the 2022 scheme's 6th semester has not started, these subjects cannot be offered as equivalent courses in advance.

## Implication for Students

Students with backlog papers in courses/subjects that have equivalent subjects in the 6th semester of the 2022 scheme will not be able to take equivalent courses for the December 2024/January 2025 examination. Instead, they must take the original 2021 scheme subject examinations.
