1.The e-Tender (Two-Cover System) is invited induplicate from eligible tenderers, registered Class-I Contractor, by the Registrar, Visvesvaraya Technological University, "Jnana Sangama", Belagavi-18, for the works detailed in the table below under standard tender document procedure KW format.
