- 2) If Markscards of all semesters and PDC are not issued, an original document/s viz marks cards/PDC signed by Registrar(Eval.) of respective University or
- 3) NAD uploaded document with verified signature and attested by the Principal

The Principals have to verify the documents of all the students submitted to the University and if any students lacks these documents, they on their own submit the aforementioned documents on or before 4.00 PM on 21st February, 2025. No individual intimation will be sent to the college by the University. Failing in submission of documents required for admission approval, will result in denial of admission, for which the respective colleges will be held responsible.
