These additional clauses will be come into effect from the academic year 2024-25

20 OB 5.3 (8) (Additional)	Readmission to 2 <sup>nd</sup> year i. 3 <sup>rd</sup> / 4 <sup>th</sup> semester is permitted only if the student has at least three academic years within the maximum permitted period of eight years
20 OB 5.3 (9) (Additional)	Readmission to 3 <sup>rd</sup> year i. 5 <sup>th</sup> / 6 <sup>th</sup> semester is permitted only if the student has at least two academic years within the maximum permitted period of eight years
20 OB 5.3 (10) (changed from 20 OB 5.3 (8))	In case of any difficulty, Vice Chancellor shall decide on individual cases, which shall be final.
