 2. Approval of Hon'ble Vice Chancellor dated 24-04-2025

With reference to the subject and reference, the following is notified:

- 1) The college shall issue the admission notification inviting applications for admission to Bachelor of Business Administration and Bachelor of Computer Applications for the academic year 2025-26.
- 2) Academic Eligibility: As notified by the University vide Notification : Notification for 2025-26
- 3) The College shall take due care while admitting students viz: verification and confirmation about the recognized board , entry level qualifications , authentication of the documents etc.
- 4) Documents to be verified : 10th marks card , 12th marks card, Transfer Certificate (TC) , Migration , Equivalence Letter / certificate issued by Association of Indian Universities , New Delhi , if passed from Foreign board - if applicable, Caste Certificate- if applicable
- 5) The College shall fill the sanctioned 100% seats following the prevailing Reservation Policy of the State. If any seats remain vacant, after two rounds of admission following merit lists, in the respective category, such seats shall be converted to General Merit seats.
- 6) The upper limit for tuition fees for the academic year 2025-26 is
 - a) Karnataka & Non-Karnataka : Rs. 45,000.
 - b) Foreign National/ PIO/NRI/ Indian students who obtained qualifying examination from abroad : 50,000/-
- 7) The University Registration fees & other fees shall be collected as notified by VTU.
- 8) Examination fees- At par with UG programmes of the University
- 9) The process shall be completed by 6th July, 2025 and list shall be submitted to the University on or before July 20, 2025

Further, the college shall meticulously follow the all the regulations and norms as notified by the University from time to time.
