With reference to the above this is to inform you that, the syllabus of the **Core Subject MEPS204 Power System Planning and Reliability** is repeated for the **Elective Subject MEPS215A** under Professional Elective-III Section in the 2nd Semester Scheme & Syllabus of the M.Tech. Power System Engineering (2024 Scheme). Hence, because of repetition of the syllabus of the Core Subject in the Elective Subject, **the syllabus for the Elective Subject MEPS215A is removed** from both the Scheme & Syllabus of the 2nd Semester M.Tech. Power System Engineering (2024 Scheme). Instead, **only following three Elective Courses are retained** in the 2nd Semester under Professional Elective-III Section.

MEPS215B Control and Integration of renewable energy sources.
MEPS215C Advanced Power System Protection
MEPS215D Thermal Science and engineering

The students are informed to opt for any one Elective Subject from the above three Elective Subjects. All the stake holders and faculty members of the colleges / institutions are requested to refresh the webpage to see the updated scheme & syllabus and are advised to refer the same for their academic planning and execution.
