A. Statutory Requirements:

- IT returns for the past 3 years (Assessment year – 2022-2023, 2023-2024 and 2024-2025)and GST / VAT returns for the financial year 2021-2022, 2022-2023 and 2023-2024.

B) Technical requirements:

At least 3 years of experience / expertise in the successful execution of similar works tendered and the cost of such any one work should not be less than 80% of estimated Amount in a single tender in any State Central Governments or Quasi Government Department or Undertaking / Universities / Colleges.
