(2025) for III to VIII Semesters - B.E./ B.Tech., Programs under OBE-CBCS

The University has prepared the **Scheme Structure** of Teaching and Examinations (2025) for **3**rd **to 8**th **semesters** of **B.E./B.Tech., programs** under the Outcome-Based Education (OBE) and Choice-Based Credit System (CBCS), effective from the academic year 2025–26. The scheme has been made available @ https://vtu.ac.in/pdf/ug2025/scheme38.pdf

Faculty members of all VTU-affiliated institutions are hereby informed to review the proposed scheme structure and provide constructive feedback. The scheme structure has been designed in alignment with the industrial requirements and the present trend. Education policy guidelines emphasize flexibility, interdisciplinary learning, and skill development.

Brief points about scheme structure:

The proposed curriculum ensures a balanced distribution of Program Core (PCC), Integrated Professional Core (IPCC), Professional Elective (PEC), and Open Elective (OEC) courses, along with Ability Enhancement (AEC) and Skill Development Components (SDC) Each semester integrates dedicated laboratories (PCC and AEC Labs) and project-based learning through Community Projects, Hackathons, and Capstone Projects (Phases I & II). A 15-week internship in the VIII semester will be facilitated via a centralized VTU internship portal, supporting multiple modes — industry, research, societal, or online. Students will have enhanced elective flexibility, with options through NPTEL, SWAYAM, and VTU Online platforms, including Foreign Language electives under the OEC category. A unique feature is the Swappable VII and VIII Semesters, allowing students to choose between:

- · Scheme-A: Traditional semester structure, or
- Scheme-B: Two-semester internship mode integrated with Capstone Projects.

All faculty members are informed to:
