As you are aware, 26th November is celebrated as **Constitution Day** to commemorate the adoption of the Constitution of India. This year's celebrations coincide with the culmination of the year-long programme themed "**Hamara Samvidhan – Hamara Swabhiman**". 2. Participation of NSS volunteers in the **Online Quiz on Constitutional Democracy** through **MyGov.in**.
3. Conduct **webinars / workshops / seminars / debates / interactive sessions** (30-60 mins) on Constitution-related themes.
4. Organise **Pledge-taking ceremonies** in all the NSS Units and upload photographs on the **My Bharat – Mega Event Portal**.
5. Conduct **community-based activities**, such as:
 - Awareness rallies promoting constitutional values.
 - Drawing/poster competitions on themes like Equality, Justice for All, Unity in Diversity.
6. Ensure **wide publicity** through institutional media/social media handles in coordination with communication teams.
7. Upload photographs, videos, and certificates of activities conducted on **social media platforms** and **constitution75.com**, as instructed.

All Programme Coordinators are requested to **ensure maximum participation of NSS volunteers** and organise the activities.

A **compliance report**, along with photographic evidence, may be submitted to this office immediately after the completion of the activities.
