1. Should be Member of Council of Architects at New Delhi & rendered consultancy services in Karnataka State & having established office in Karnataka State.:
2. The empanelment shall be based on details including profile of the organization, works carried out and input from the past clientele and will be evaluated by the Technical Committee authorized by Hon'ble Vice-Chancellor, VTU.
3. Participant Architect / Architectural firms should have rendered consultancy services & completed University buildings in the previous **Five (5)** successive years, each building costing not less than **Rs.10.00 Crores for Category-I & Rs.5.00 Crores Category-II.**
4. The Architect firms shall submit List of all works carried out (both completed and ongoing) in the last 3 years.
5. The detailed profile/Bio-data of the firm & other required documents shall be submitted through KPP Portal **From 11-11-2025 to 25-11-2025 upto 4.00 PM.**
6. Work done previously for University Buildings/Govt./Quassi/Public Sector Buildings will be considered for qualification.
7. The Registrar, V.T.U., Belagavi reserves the right to accept/reject any or all the tenders without assigning any reasons.
