In previous instances, it has been noted by the University that few colleges have submitted incomplete documents of students for admission approvals. The marks cards of many students issued by the University have not been submitted. It has to be noted that while according admission approval, the University has to ensure that the student has completed the degree in all respects and satisfy the minimum academic eligibility to seek admission to the PG programmes of this University. Hence, following shall be submitted, without which the admission approval will not be accorded to such candidate.
