Subject: Professional Elective Courses (PEC) and Open Elective Courses (OEC) lists of schemes 2022 (UG Engineering programmes) regarding...
Reference: VTU/BGM/PEC-OEC /857/2025-26/4378, Dated: 25.11.2025

As per the **2022 Scheme**, students of the **VIII Semester** are required to complete the following components:

- **Internship - Bxx883 (Scheme A)**
- **One Professional Elective Course (PEC - Bxx811x)**
- **One Open Elective Course (OEC - Bxx812x)**

All VIII semester students must complete the PEC and OEC through **online mode** by selecting courses from the **BoS-approved list** made available by the University. It is observed that, in the scheme pages of the programmes: Civil Engineering, Biomedical Engineering and Electronics and Instrumentation Engineering, certain courses listed were selected from **NPTEL during the academic year 2023-24**. Some of these courses may no longer be available for selection or study on the NPTEL platform.

The currently approved PEC and OEC courses for the VIII semester are made available for selection, study, and examination at the following link:

Students are advised to select both PEC and OEC courses only from the list provided at the above link.

While selecting PEC and OEC courses, the following guidelines must be strictly followed:

- **Open Elective Course (OEC):**
The course must be chosen from other branches/disciplines and should be multidisciplinary in nature.
- **Professional Elective Course (PEC):**
The course must be selected within the same branch/discipline.
- Students must ensure correct categorization of PEC and OEC during registration.
- Courses selected should not partially or fully overlap with courses already studied in previous semesters.
- Examinations for PEC and OEC will be conducted by VTU in online mode.
- Students are strongly advised to consult their mentor/guide before finalizing the selection of PEC and OEC courses. In case of any doubt or clarification, mentors/guides may contact the University.

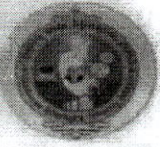

- A Professional Elective Course (PEC) refers to a course selected from within the same branch/discipline. Students are advised to carefully ensure the correct categorization of their elective choices while registering.
- Selection of course: Students must select a program from the approved PEC/OEC course list.
- Exams for these courses will be conducted by VTU and it will be online mode.
- The courses selected should not map partly or fully with the courses that already studied
