Please Note:

For the students admitted in the academic year 2024-25.

1. The registration process for the Summer Semester shall begin from the date of notification of this Academic Calendar and shall remain open up to 31.07.2026 for all UG programmes.
2. Eligibility for registration to SUMMER SEMESTER:
 - a. Students are eligible to register for the Summer Semester for courses of the I to IV Semesters in which they have secured DX, NS or NP grades, or for courses that were dropped/withdrawn, to facilitate slow learners in completing their studies. Note: DX denotes courses with shortage of attendance, non-qualification in CIE, or both shortage of attendance and non-qualification in CIE. NS or NP denotes non-qualification in mandatory non-credit courses.
 - b. A student shall be permitted to register for a maximum of 14 credits in UG programmes during the Summer Semester, excluding Mandatory Non-credit Courses. However, for the Architecture programme, a student may register for a maximum of 18 credits.
 - c. For the courses registered, the student shall attend the prescribed classes, fulfil the attendance and Continuous Internal Evaluation (CIE) requirements, and become eligible

to appear for the Semester End Examination (SEE). The principals of the concerned colleges shall submit the list of such students registered for the Summer Semester to the Registrar, VTU, Belagavi, with a copy to the Registrar (Evaluation), immediately after the last date prescribed for registration.

- d. There shall be no limit on the number of 'F' or 'AB' grade courses for which a student may register for the Summer Semester End Examination (SSEE). Students having 'F' or 'AB' grades are not required to attend Summer Semester classes. They may directly apply for the SSEE by submitting the prescribed examination application whenever notified and appear for the examination.
3. The above provisions are applicable to students admitted to 1st year of the UG programmes in the academic year 2024-25. This is also applicable to the students who have taken readmission to III semester during AY 2025-26 from different scheme to 2022 scheme.
4. The college must plan for extra sessions on weekdays, Saturdays, and Sundays to complete the requisite hours of the academic term of the SUMMER SEMESTER.
5. All faculty and staff are required to be available to undertake any work assigned by the University during the summer semester period.
6. Notifications regarding the Calendar of Events for the conduct of SUMMER SEMESTER END EXAMINATION (SSEE) will be notified by the Registrar (Evaluation).
7. Autonomous Colleges shall strictly adhere to the Academic Calendar notified by the University. The commencement and closure of classes, as well as the conduct of examinations, shall be in accordance with the schedule announced by the University. In the event of any deviation from the prescribed schedule, the principal shall submit the reasons for such deviation to the University. The University may review the matter and issue appropriate directions to ensure compliance with the Academic Calendar.
8. Any modification to the academic terms or examination schedule due to exigencies shall be made only with the prior approval of the University.
